



A Freedom Declaration For America: Part III, The Solution

WHEN A PEOPLE find themselves besieged by tyranny, they are obligated to reassert their authority over their government and reestablish it upon principles of Freedom, Liberty and Independence.

Our Rights

“We the People” are the source of all political power. As individuals we are equal and hold unalienable rights from our Creator including the right to Life, Liberty and Property. It is our right to abolish or alter our government to protect our rights and Freedoms, and to increase happiness, peace, and security. No entity shall deprive us of these rights and violation of any right is unacceptable. When the force of government is abused, the result is fear and tyranny. Toleration of any abuse opens the door for further abuses. The repression of any individual or group is of personal concern to us all. We allow limitation of individual Liberty at the loss of our precious Freedom.

Our Situation

The Constitution is a “rule book” which explains what our federal government can and cannot do. The list of abuses and usurpations committed by our government against the Constitution is too large to cover in this document. The effects of these encroachments are visible in our daily lives. The wealth and productivity of our nation has been stifled and America is now dependent on and indebted to other nations. Our personal Freedom and Independence are being both openly and secretly erased. Our representatives have created these problems by breaking their oath to obey and defend the Constitution. We hold each one accountable for the breach of their oath.

These dangerous times are sapping the life out of society and causing venomous division. Continuous war is corrupting our nation. We support our military, but abhor its service in undeclared and unconstitutional wars. These wars have done

nothing to increase our security but have cost trillions of dollars, ended many lives, and excessively enlarged the national debt. The cost of priceless human life is needless and inexcusable.

We cannot remain free and independent without proper government accountability to “We the People”. For over a century the scope and aggressiveness of government tyranny has expanded menacingly. Several key examples will show the danger we are in.

Top Grievances

Congress has violated their oath to uphold and defend the Constitution by knowingly allowing violation of constitutional powers by all branches of government.

The President is in violation of his oath of office and has committed acts of treason which must be immediately overturned. He must promptly step down or be removed by due process of law. All illegal executive orders must be immediately rescinded.

In 1913, the Federal Reserve was illegally created to control American money. It creates mountains of debt while making our money worthless. The 16th Amendment of 1913 also alters the law to allow the government to collect income tax, robbing us of our wealth. The results have been the decrease of small businesses and national prosperity. The Federal Reserve and Internal Revenue Service must immediately be dissolved.

Security cannot be purchased at the price of essential Freedom. Yet, the government has passed laws and created agencies in the name of security which erode our fundamental rights of habeas corpus, due process of law, Freedom of speech, and personal privacy -including the Patriot Act, NDAA, TSA, NSA, DHS, BATF and many more.

The Patient Protection and Affordable Care Act of 2009 (Obamacare) significantly restricts private choice and puts the medical field under government control. Many

Part I, Preface

Freedoms are lost as a result of these 2700 pages of unread, unconstitutional legislation.

We have been gradually placed under martial law and slavery. Our civil authority has been sacrificed to military jurisdiction. The United States is now an illegal battlefield in the international war on terrorism.

Massive election fraud has stolen the voice of the People and created an oligarchy of private entities and public officials which illegally governs the nation.

America's Independence and sovereignty has been sold out to international organizations such as the United Nations, the North Atlantic Treaty Organization and World Bankers.

We declare that the Constitution was written only for a moral and religious people. Government has violated its mandate to never interfere with religious freedom, thus promoting irreligion and incurring the wrath of a just God.

Our Situation

For decades, our representatives have worked to make themselves masters over us. "We the People" will not surrender our rights. Our choice is between Freedom and slavery – and the time to choose is now! We must reduce the size of government by eliminating unconstitutional agencies and the excessive number of government employees. The Constitution is the Supreme Law of the land and cannot be violated without consequences. Unless we change our course, the government will plummet further into despotism, the Union will be broken up, and chaos will reign. We demand that Congress, the President and the Supreme Court cease and desist from their unlawful acts and abide by the powers enumerated in the U.S. Constitution or the People will legally remove them from their post. We finally declare with one voice that "We the People of the United States" will forever uphold Liberty with our Lives, our Fortunes, and our Sacred Honor, so help us God.
